STATUS REPORT

On March 21, 2019, this Court ordered that “Defendants shall file a status report no later than April 3, 2019 at 12:00 p.m. providing an update as to defense counsels’ consultation with their clients regarding the provision to USCIS of information about MAVNI enlistees.” (*See* minute order of March 21, 2019.)

Since the hearing on March 20, 2019, Army, DoD, and USCIS representatives and counsel have engaged in discussions regarding the significant challenges to be overcome in order to share information at the MSSR stage. Although higher level discussions continue, the agencies have concluded that the existing process of issuing the final MSSD is, at present, the most efficient way to share the necessary information for the large majority of the remaining *Nio* class members. Thus, in all likelihood the majority of the remaining *Nio* class members will have their naturalization applications adjudicated after the *Calixto* due process procedure is complete for them and the Army issues a final MSSD.
