DEFENDANTS' SEPTEMBER 18, 2019 REPORT TO THE COURT

In accordance with this Court's August 14, 2019 Order (ECF No. 266), and based on information provided to the Department of Justice from the Department of Defense, the Army, and U.S. Citizenship and Immigration Services ("USCIS"), Defendants submit the attached Six-Week Report. Notably, the attached report does not include information on *Nio* class members who were naturalized prior to Defendants' last report of August 7, 2019 (ECF No. 264). However, the attached Six-Week Report includes the following information regarding class members who have pending naturalization applications, those who have naturalized since the last report, and those who have been denied naturalization:

- a. Enlistment Date
- b. Naturalization Application Filing Date
- c. CI Report Completion Date
- d. MSSR Result (recommend/non-recommend/pending/NA)
- e. MSSR Date (blank if pending/NA if no MSSR will be issued)
- f. Date MSSR Notification (Pursuant to 10/26/18 Memo) Sent to Class Member
- g. MSSD Completion Date (blank if pending)

- h. MSSD Result (suitable/unsuitable/pending)
- i. Effective Discharge Date (blank if not discharged)
- j. Discharge Revoked? (yes/no)
- k. Date MSSR Report provided to USCIS
- l. Date CI Report provided to USCIS
- m. Date materials provided to FDNS
- n. Date USCIS sent the individual's materials to FOD
- o. Date materials provided to NBC
- p. Date materials provided to USCIS field office
- q. Naturalization Interview Scheduled? (yes/no)
- r. Date Naturalization Interview Completed (blank if not scheduled)
- s. Naturalization Case Status (approved/denied/withdrawn/pending)
- t. Naturalization Date (blank if not naturalized).

The attached report reflects that, as of September 16, 2019, a total of 1,394 former *Nio* class members are now United States citizens. 81 individuals naturalized since Defendants' last Six-Week Report. There are now 612 class members with pending naturalization applications. Of those, 188 have already been interviewed, and 122 have interviews scheduled.

USCIS informs DOJ that USCIS continues to prioritize the processing of naturalization applications of class members who have received MSSR Notification Letters pursuant to the Army's October 26, 2018 policy. Additionally, "Column J" of the excel spreadsheet reports 134 additional MSSR Notification Letters pursuant to the Army's October 26, 2018 policy letters were sent to *Nio* class members with pending naturalization applications since September 4, 2019 (ECF No. 271). USCIS will prioritize these applications in addition to the names previous provided by the Army. At

this time, 271 soldiers have received an MSSR notification letter and have a pending naturalization application.

In response to the Court’s order that counsel for both parties meet and confer regarding specific areas of confusion or disagreement, USCIS reports that it has reviewed each inquiry sent to the *Nio* email inbox from class counsel, addressed any actionable issue raised (*i.e.*, if a Request for Evidence (RFE) has been improperly sent to a class member), and responded to class counsel to confirm that the issue has been reviewed.¹ USCIS has not, however, responded to any inquiry from class counsel regarding an area that is not in dispute. For example, USCIS has not provided reasoning to class counsel as to why an adjudicator may not issue a decision on an application before 120 days have passed from the date of interview. *See* 8 U.S.C. § 1447(b).

In the September 4, 2019 report to the court, USCIS stated that it would provide an additional update regarding the seven individuals who were denied naturalization based solely on a purported uncharacterized discharge. The status of each of these applicants’ applications is as follows:
