Class member [PII REDACTED] was interviewed for naturalization on February 12 at the Philadelphia field office by USCIS Officer McCall (see attached N-652). However, the officer who interviewed this soldier was uninformed about the Court's preliminary injunction in this case and said that the only reason the soldier could not be recommended for approval was because the soldier's N-426, signed by the soldier's commanding officer who was a Captain at that time, in January 2017, is not valid. As you know, Defendants are not allowed to revoke or otherwise invalidate MAVNI soldiers' N-426s.

Nonetheless, at the February 12 interview, the soldier provided another N-426, certified by Colonel Brian Thomas, which establishes that the soldier is honorably serving and eligible for naturalization. However, the USCIS officer informed the soldier that this N-426 is not adequate and that he needed a "new updated and original" N-426 form. On February 18, the USCIS officer called the soldier and asked if the soldier received a letter requiring that a new N-426 be provided to USCIS (which the soldier has not yet received). Please ensure that this officer, this field office, and all relevant USCIS personnel are aware of the Court's Orders in this case and the related cases and Defendants' representations regarding the same.

Please confirm by email that this soldier's N-426 has not been revoked or invalidated, that USCIS is revoking the request for a new N-426, and that USCIS is not waiting (and will not be waiting) on another N-426 or other verification from the Army concerning this soldier's service.
