JOINT STATUS REPORT REGARDING MEDIATION

Pursuant to this Court’s March 8, 2022 Order, the Parties provide this joint status report “(1) informing the Court as to the status of mediation (without revealing the content of their settlement discussions), and (2) indicating whether they wish to engage in further mediation.” Dkt. 233.

The Parties have provided mediation statements and engaged in multiple mediation sessions with Judge Teel and are working cooperatively in an effort to resolve this matter without further litigation. The Parties wish to continue this mediation. The next session with Judge Teel is scheduled for April 13, 2022. In addition, in order to allow the Parties to focus on potential resolution, the Parties intend to soon file another joint motion asking the Court to extend certain deadlines in the litigation – pushing those deadlines by three weeks from April 15, 2022 to May 6, 2022.
